Notice

Under Art. 18 of the Study Code of the Faculty of Pharmacy, Comenius University Bratislava (hereinafter "SC"), a student may apply in written form for recognition of completed courses, credits, and grades from previous unfinished studies, **if no more than 4 years have elapsed since they acquired bachelor's study and no more than 5 years in 1st and 2nd degree of master's study**, and their completion was evaluated with a grade of A to D, no later than the day of the beginning of study in winter semester. The application must be submitted with a **confirmed Transcript of study results** of completed courses and **syllabi** of courses. The Dean decides on recognizing courses, credits, and grades based on the guarantor's statement of relevant study programme. Altogether, **in one academic year**, the student can have recognized courses in **max value of 50 credits**.
